

ONCOLOGY NURSING SOCIETY CHEMOTHERAPY AND BIOTHERAPY COURSE

PROGRAM DESCRIPTIONS AND OPTIONS:

- **OPTION 1:** The Oncology Nursing Society **TWO-DAY DIDACTIC** course provides a comprehensive review of the knowledge needed to administer cytotoxic and biotherapeutic agents.

Upon successful completion of the course and post-test, participants will receive an ONS Chemotherapy and Biotherapy Provider Card. This card validates the participant has the theoretical foundation needed to administer cytotoxic and biotherapeutic agents. The card is valid for two years.

- **OPTION 2:** The Oncology Nursing Society **TWO-DAY DIDACTIC plus A THIRD DIDACTIC DAY**, taught by an interdisciplinary team of professionals and designed to supplement your learning. (See Third Day Topics which follow).
- **OPTION 3: The TWO OR THREE DAY DIDACTIC plus PRACTICUM** course provides an additional three-day clinical experience in Fox Chase Cancer Center's Infusion Room. Acceptance into the Practicum Course is contingent on meeting established criteria which includes: proof of current RN licensure, malpractice insurance, IV certification, and competency related to the management of vascular access devices. Nurses accepted into the Practicum Course are required to have a minimum of one-year oncology experience and expect to be administering chemotherapy on a regular basis in their practice.

TARGET AUDIENCE:

Participants must be licensed registered nurses who had been employed as such for a minimum of six months. This course content is appropriate for nurses who are new to chemotherapy administration, as well as for those who want a comprehensive review.

CONTINUING EDUCATION CREDIT:

- **PROGRAM OPTION 1: ONS Chemotherapy and Biotherapy Course.**

ONS will award 13.5 contact hours to nurses who attend this program in its entirety.

ONS is accredited as a provider of continuing nursing education by the American Nurses Credentialing Center's Commission on Accreditation.

ONS is approved as a provider of continuing education by the California State Board of Registered Nursing, Provider No. 2580.

- **PROGRAM OPTIONS 2 and 3:** FOX CHASE CANCER CENTER will award 6.5 continuing education hours to nurses who attend the 3rd optional didactic day in its entirety. An additional 18 continuing education hours will be awarded to those successfully completing the clinical Practicum program. Fox Chase Cancer Center is an approved provider of continuing nursing education by the PA State Nurses Association, an accredited approver by the American Nurses Credentialing Center's Commission on Accreditation.

ADDITIONAL INFORMATION:

The ONS Chemotherapy and Biotherapy Course, Fox Chase Cancer Center third supplemental educational-day and Clinical Practicum are **NOT** certification courses and are not intended to measure competency. Individual institutions are responsible for determining their own requirements based on internal policies for assessing clinical competency in chemotherapy and biotherapy administration. It is the responsibility of each nurse administering chemotherapy and biotherapy to acquire updates on new drugs, administration techniques and other practice issues.

ONS CHEMOTHERAPY AND BIOTHERAPY COURSE OBJECTIVES:

Upon completion of the course, the participant will be able to:

- Identify various therapeutic modalities used to treat cancer with emphasis on chemotherapy and biotherapy.
- Describe the investigational process all drugs undergo to gain approval for use.
- Review ethical and legal issues related to cancer therapy.
- Identify factors affecting response to cancer therapy.
- Identify selected commonly used agents, their mechanisms of action, and any unique administration issues.
- Discuss safety precautions necessary when handling cytotoxic agents.
- Review chemotherapy dose calculations and practice examples.
- Identify nursing procedures and interventions for administering cytotoxic and biologic agents.
- Discuss two immediate complications of cancer therapy, extravasation and hypersensitivity, and the nursing measures required to prevent and/or reduce these complications.
- Identify selected systematic side effects of cytotoxic and biotherapeutic agents and the nursing interventions required to manage these side effects.
- Review specific patient and family education that may prevent and/or reduce the impact of systemic side effects.

THIRD DAY OBJECTIVES:

Upon completion of the course, the participant will be able to:

- A. Review key factors to consider when performing venipuncture.
- B. Discuss the maintenance and care of access devices and the prevention of complications to improve clinical outcomes.
- C. Explore nursing strategies to prevent medication errors.
- D. Discuss pharmacogenomics as related to oncology care and chemotherapy/ biotherapy administration.
- E. Review issues related to complementary therapy during chemotherapy/ biotherapy treatment.
- F. Discuss the psychosocial issues faced by patients and their families during chemotherapy/ biotherapy treatment.

3-DAY PRACTICUM COURSE OBJECTIVES:

At the completion of this course the participant will be able to:

- Demonstrate/discuss safe handling and disposal of chemotherapy/biotherapy agents.
- Demonstrate/discuss correct administration of parenteral chemotherapy/biotherapy agents including vesicants.
- Develop/describe an effective teaching plan for patients/families receiving treatment.
